Development of regional cycling and walking paths network	1.Hiking: Klaipeda region and Kurzeme are crossed by 2 long distance hiking trails E9 Baltic coastal hiking route and E11 Forest trail. Both regions have developed also rather good short distance hiking trails, each trail between 0.5km-up to 7 km in the nature protected areas, nearby and in the towns, near by nature objects (lakes, rivers, parks). In Kurzeme there are over 60 nature trails and in Klaipeda region xx (???) trails. Demand for nature tourism products is growing, people are looking for the options to spend holidays in active way in the nature, meanwhile also expectation for the readiness of products are raising. Travellers are looking for ready-made routes with the available services around/start/finish destinations – catering, accommodation, attractions, qualitative information online and good cartography maps.
	 The aim of the project is to develop connections between the both long distance hiking trails (Coastal hiking route and Forest trail) by creating medium distance trails (20km – 35/50 km), which will serve for 2-3 days/weekend hikes. It is expected that new developed connections will cross valuable nature and landscape areas as well will connect tourism service hubs (villages, towns). As a result: Network of hiking trails all over the Klaipeda and Kurzeme regions would be established - both regions would be more friendly and open to nature tourism travellers, Tourism seasonality will be expanded, as hiking is more intense beyond the traditional tourism season in summer, and is more spring/autumn season activity. Kurzeme and Klaipeda regions would be promoted as hiking destinations towards local target markets, markets across the border and foreigner markets. Small scale infrastructure (signposting, information stands, resting areas) to welcome hikers and make trails feasible and recognized in the nature. Partners expected: Regional level tourism planners/experts, which are ready to proceed with the identification of trails, confirmation of tracks within all parties (nature territories, municipalities, private) as well to ensure implementation of marketing activities (online, travel guides, campaigns) Municipalities – to develop small scale infrastructure




2.Cycling:

Eurovelo 10 and 13 is crossing Klaipeda and Kurzeme regions. There are in Kurzeme region 35 routes, which have applied for the route number within national system of route development and have obtained status of local cycling routes. There is 1 regional route – Forest trail in Kurzeme by bicycle, track partly overlaps with Forest hiking route, but in some sections different roads are used to fit better for cyclists. Klaipeda region has (...??) routes.

During last 5 years active improvement of local roads/city/town streets is ongoing. New cycling paths/new green areas regenerated and are available for cycling, walking etc. active leisure. That requires to revise cycling routes network, developed back in 2012 in Kurzeme and update it by adding new routes and connections and harmonizing existing routes to fit the best into the upgraded infrastructure.

There is also a demand to develop regional network of routes, which would be at least 100-300 km long and would offer possibility to discover whole region on the bicycle wheels.
