This year is special because 1 November will mark the 30<sup>th</sup> anniversary of the entry into force of the **Maastricht Treaty** which created **Union Citizenship**. This is an opportunity to think about the meaning of European Citizenship, what it has achieved so far, where it is today and its future prospects.

Celebrating an anniversary means standing back, reflecting and debating new ideas. It is a chance for **academics**, **civil society activists** and **policy makers** who have come together at previous <u>Annual Conferences</u> to think beyond their immediate interests and concerns.

How did Union Citizenship come about? What has been the track record? A public relations exercise or the first post-national citizenship of the modern era? Such contrasting views expressed at the time of the Maastricht Treaty have tended to converge. There has been extensive case law in the European Court and updated legislation to strengthen European rights to freedom of movement in the areas of residence rights, access to social security and recognition of qualifications. Yet many barriers still remain especially for job seekers, minorities, and low-income groups. More fundamental questions posed at the time of Maastricht persist. Is Union Citizenship too exclusive? Was enough done, for example, to reduce the gap between mobile EU citizens and citizens from the rest of the world?

The 30<sup>th</sup> anniversary should be about taking the plunge and imagining how this unique transnational citizenship could become more relevant to all Europeans and strike the popular imagination.

- What has changed in Europe since the more optimistic period of the Maastricht Treaty and a series of crises leading up to the Russian war on Ukraine?
- Does the new situation in Europe strengthen the case for a more inclusive and outward-looking European Citizenship?



- Could Union Citizenship be developed with new rights- democratic, social, environmental or health rights to become a citizenship more relevant for those that stay at home, and not just for mobile citizens?
- How to promote the ECIT project for <u>a Statute on European Citizenship</u> which has been supported by the European Parliament and the Conference on the Future of Europe? Could this be the framework to bring what exists and new rights together for the next 30 years?

This is a hybrid event with about 50 participants on the spot being joined online by remote participants throughout the day and for particular sessions.

The first session in the afternoon is part of the Work Package 3 "Tools for boosting citizens' engagement. Participatory democracy of the NOTE (Network of Organisations and Towns for the European elections) project, funded by the CERV programme of the EU. The partners in the project will be joining on-line to explain the focus of the project on street debates and a practical toolkit to involve voters in the 2024 European elections.
